### ACT No. X of 1980

*AN ACT further to amend the National Day and other Public Holidays Act, 1975.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the National Day and other Public Holidays (Amendment) Act, 1980, and shall be read and construed as one with the National Day and other Public Holidays Act, 1975, hereinafter referred to as “the principal Act”.

Substitution of section 2 of the principal Act.

2. For section 2 of the principal Act there shall be substituted the following:

“Jum il-Helsien to be National Day of Malta.

2. (1) The thirty-first day of March of each year shall be known as Jum il-Helsien and shall be the National Day of Malta.

(2) Jum il-Helsien shall be a public holiday and on that occasion there shall be flown on all public buildings the National Flag of Malta.

(3) The Prime Minister shall give such directions as he may deem appropriate for the due celebration of Jum il-Helsien.”

Substitution of Schedule to the principal Act.

3. For the Schedule to the principal Act there shall be substituted the following:
