ACT No. XXXIII of 1981

AN ACT further to amend the Import Duties Act, 1976.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the Import Duties (Amendment) (No. 2) Act, 1981, and shall be read and construed as one with the Import Duties Act, 1976, hereinafter referred to as “the principal Act”.

Amendment of First Schedule to the principal Act.

2. The First Schedule to the principal Act shall have effect subject to the amendments set out in the Schedule to this Act.

SCHEDULE

1. For heading number 71.12 and for the figures in respect thereof in the second and third columns there shall be substituted respectively the heading shown in the first column and the relative figures shown in the second and third columns hereunder:
