AN ACT to amend the Malta Travel and Tourism Services Act, Cap. 409.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by authority of the same as follows:-

Short title.

1. The short title of this Act is the Malta Travel and Tourism Services (Amendment) Act, 2025 and this Act shall be read and construed as one with the Malta Travel and Tourism Services Act, hereinafter referred to as the "principal Act".

Cap. 409.

Addition of a new article to the principal Act.

2. Immediately after article 46 of the principal Act there shall be added the following new article:

"Language of the regulations.

46A. Regulations which are required to be issued by the Minister on the recommendation of the Authority or after consultation therewith under this Act may be made in the English language only."

Objects and Reasons

The scope of the proposed amendment is so that regulations made by the Minister on the recommendation of the Malta Tourism Authority under the Act may be published in English only in accordance with the established practice in the tourism sector.
