In reference to our clarification dated 25 February 2025 regarding the €7.2 million infrastructure expenditure incurred between 2019 and 2022, as highlighted in the NAO's Performance Audit, the Malta Film Commission had presented a detailed breakdown of the total expenditure by category.

Each commitment number submitted corresponds to a specific transaction. As already indicated in our reply of 25 February 2025, the disbursements were effected directly by the Ministry to duly vetted suppliers and service providers, in line with established procedures. Further payments were executed by the Malta Film Commission upon receipt of the allocated funds from the Ministry, also in accordance with standard procedures.

We hereby reconfirm that all allocated funds were utilised strictly for their intended purpose and in full adherence to the applicable public sector governance and accountability standards.
