**MALTESE CITIZENSHIP ACT
(CAP. 188)**

Agents (Licences) (Repeal) Regulations, 2026

IN EXERCISE of the powers conferred by article 24 of the Maltese Citizenship Act, the President of Malta has made the following regulations:-

Citation. **1.** The title of these regulations is the Agents (Licences) (Repeal) Regulations, 2026.

Repeal and saving.
S.L. 188.05. **2.** (1) The Agents (Licences) Regulations are hereby repealed:

S.L. 188.05. Provided that the provisions of the Agents (Licences) Regulations shall continue to apply to those persons who were holders on 29 April 2025 of a valid and effective licence issued under the Agents (Licences) Regulations, which licence shall remain valid only for the purpose of the implementation of such provisions of the Agents (Licences) Regulations as well as the Granting of Citizenship by Naturalisation on the basis of Merit Regulations, the Individual Investor Programme of the Republic of Malta Regulations and the Community Malta Agency (Establishment) Order as in force on the 29 April 2025, whether by virtue of a transitory provision or otherwise, until such provisions shall cease to be so applicable.

S.L. 188.05. (2) The retention of such licence in accordance with the provisions of the Agents (Licences) Regulations shall not be subjected to any licence fee and shall be deemed to be automatically renewed for as long as is necessary for the purposes of the proviso to sub-regulation (1), and subject to the provisions of the Agents (Licences) Regulations.
