

**NOMINA TAS-SUR ANTHONY MICELI DEMAJO GHALL-HATRA
TA' AMBAXXATUR TA' MALTA MHUX RESIDENTI GHALL-ORDNI SOVRANA
MILITARI TA' MALTA**

Mistoqsijiet sottomessi mill-Membri tal-Gvern

1. X'taħseb li huma l-isfidi li qed tara fil-pajjiż rispettiv fejn se tinħatar bħala Ambaxxatur?
U kif qieghed tara dawn l-isfidi jiġu indirizzati f'dan il-pajjiż?

SMOM has just passed from a reform of its statutes and constitutional reforms, a process that has been going on for a number of years and its only now that it has started to see the fruit of its cohesion and fidelity. Towards its founding charisma I believe that in the very near future SMOM will be in a position to start focussing again much more on its humanitarian works, than its internal divisions.

2. X'inhuma l-binarji, b'mod ġenerali, li beħsiebek taħdem fuqhom f'każ li tinħatar Ambaxxatur?

It is my wish that I keep on strengthening the historical and cultural ties that already exist between Malta and SMOM, including maybe, more humanitarian collaboration in the Mediterranean.

3. Bħala Ambaxxatur, kif tara li x-xogħol tiegħek jista' jwassal sabiex jiżdiedu u jitjiebu r-rabtiet politiċi u soċjali ma' pajjiżna?

It would be my wish as Ambassador to build trust – dialogue and reciprocal respect regularly at Diplomatic level and collaboration on common priorities. I wish to work so that Malta and the Order will work together on global humanitarian issues. This will strengthen the ties with us bilaterally and also on an international level. We must not lose sight of the fact that they are a small State that have observer status at UN level (considered a Sovereign entity under International Law).

4. Liema taħseb li huma l-isfidi prinċipali li għandna negħlbu sabiex insaħħu r-relazzjoni bejn iż-żewġ pajjiżi?

The Historical and Cultural ties. More activities. Focus more on challenges for climate change and AI.

5. X'taħseb li huma n-niċċ li nistgħu nsibu sinerġiji fuqhom bejn Malta u l-pajjiż rispettiv li int se tkun se tirrapreżenta lil pajjiżna?

Humanitarian Aid that could strengthen assistance to Maltese NGO's involved on this subject. SMOM have Cisom in Italy (Corpo Italiano di Soccorso ordine di Malta). Doctors - Medics – Nurses and many others, all on a voluntary basis.

6. Kif tara li għandna nsaħħu r-relazzjonijiet kummerċjali u ekonomiċi bejn iż-żewġ pajjiżi rispettivi?

On the medical sector – joint initiatives on medical equipment – Cultural Tourism to be directed to all Associations Worldwide with more activities at Fort St. Angelo and the SMOM Embassy in Valletta.

7. F'dan ir-rigward, tara li hemm trattati li jistgħu jithaddmu aħjar bejn iż-żewġ pajjiżi? Jew trattati oħra li għandhom jiġu esplorati għaż-żmien li ġej?

I am oblivious of the treaties or agreements Malta has with the Order. But certainly jointly on Human trafficking.

8. Taħseb li hemm lok għal iżjed koperazzjoni fil-qasam tat-turiżmu bejn iż-żewġ pajjiżi rispettivi?

Along with the MTA we can market Malta with all the SMOM associations, priories and sub-priories Internationally. In the USA alone SMOM have 12,000 members.

9. Fuq livell ta' politika Ewropea u Internazzjonali, tara bejn iż-żewġ pajjiżi rispettivi li jistgħu isaħħu l-koperazzjoni bejniethom b'mod partikolari fuq livell ta' Unjoni Ewropea?

Although Malta is not a Religious State, we share common values with SMOM, mostly on Human dignity and I am convinced that working in tandem on International sectors with the United Nations and the European Union.

10. Tista' tispjega lill-Kumitat dwar jekk kontx involut matul il-karriera tiegħek fi hdan il-Korp Diplomatiku u/jew il-Ministeru tal-Affarijiet Barranin?

Yes, as non resident Ambassador to Romania. Vide my CV.

11. Tista' tindika x'karigi għandek fil-preżent u jekk kemm-il darba tinħatar bhala Ambaxxatur, hux se tkun qed iżżomm xi kariga minnhom?

Yes, only on an Honorary capacity as President of The Demajo Group for family Governance and as a Director of M. Demajo Holdings Ltd., which shares now belong to my two children as curator.

No commercial interests.

Its role involves the strengthening of Cooperation in the fields of Historical – Cultural and Humanitarian, in the light of common ties close to Malta and the Order. The Ambassador also facilitates dialogue on subjects of common interest, in particular those related to humanitarian activities. Mainly Healthcare and International Diplomacy.
