*ATT biex jemenda l-Att dwar il-Portijiet Hielsa ta' Malta (Kap. 334).*

IL-PRESIDENT bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità ta' l-istess, hareġ b'ligi dan li ġej:-

1. It-titolu fil-qosor ta' dan l-Att huwa l-Att ta' 1-2008 li jemenda l-Att dwar il-Portijiet Hielsa ta' Malta, u dan l-Att għandu jinqara u jinftiehem haġa waħda ma' l-Att dwar il-Portijiet Hielsa ta' Malta, minn hawn 'il quddiem imsejjaħ "l-Att prinċipali".

Titolu fil-qosor.

2. Il-paragrafu (c) tas-subartikolu (1) ta' l-artikolu 6 ta' l-Att prinċipali għandu jiġi emendat kif ġej:

(a) fit-tieni proviso tiegħu, minflok il-kliem "m'għandux jitqies li jkun titolu simili għal bejgħ;" għandhom jidhru l-kliem "m'għandux jitqies li jkun titolu simili għal bejgħ;" u

(b) minnufih wara l-imsemmi tieni proviso, għandu jżdid dan il-proviso ġdid li ġej:

"Izda wkoll l-Awtorità, bl-approvazzjoni tal-Ministru u skond il-paragrafi (a), (b), (d), (e) jew (f) tas-subartikolu (1) ta' l-artikolu 3 ta' l-Att dwar it-Trasferiment ta' Artijiet tal-Gvern, tista' tohloq servitujiet u drittijiet oħra simili fuq arei kompriżi f'żona ta' Port

Hieles favur art oħra li tinsab barra zona ta' Port Hieles kull meta dawn id-drittijiet ikunu meħtiega għall-użu xieraq ta' din l-art;".

3. Fl-artikolu 4(1) ta' l-Att prinċipali, il-kliem "Id-dispożizzjonijiet ta' l-Att dwar it-Trasferiment ta' Artijiet tal-Gvern" għandhom jiġu sostitwiti bil-kliem "Hief kif provdut xort' oħra f' dan l-Att, id-dispożizzjonijiet ta' l-Att dwar it-Trasferiment ta' Artijiet tal-Gvern".

**ACT No. X of 2008**

*AN ACT to amend the Malta Freeports Act (Cap. 334).*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:

1. The short title of this Act is the Malta Freeports (Amendment) Act, 2008, and this Act shall be read and construed as one with the Malta Freeports Act, hereinafter referred to as "the principal Act".

Short title.

Cap. 334.

2. Paragraph (c) of subarticle (1) of article 6 of the principal Act shall be amended as follows:

Amendment of article 6 of the principal Act.

(a) in the second proviso thereof, for the words "shall not be considered to be a title similar to sale;" there shall be substituted the words "shall not be considered to be a title similar to sale:"; and

(b) immediately after the said second proviso, there shall be added the following new proviso:

"Provided further that the Authority may, with the approval of the Minister and in accordance with paragraphs (a), (b), (d), (e) or (f) of sub-article (1) of article 3 of the Disposal of Government Land Act, create

servitudes and other similar rights over areas comprised within a Freeport zone in favour of any land outside the Freeport Zone whenever such rights are required for the proper use of such land;"

Amendment of  
article 4 of the  
principal Act.

3. In article 4(1) of the principal Act the words "The provisions of the Disposal of Government Land Act" shall be substituted by the words "Except as otherwise provided in this Act, the provisions of the Disposal of Government Land Act".
