**ACT No. XVI of 2005**

*AN ACT to appropriate a sum not exceeding sixty-three million, nine hundred and thirteen thousand Maltese liri for the service of the financial year 2005.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

**1.** This Act may be cited as the Second (2005) Appropriation Act, 2005.

Appropriation 2005.

**2.** A sum not exceeding sixty-three million, nine hundred and twelve thousand, nine hundred and ninety-four Maltese liri to meet expenditure in respect of financial year 2005 under the Votes specified in the First Schedule to this Act shall be and the same is hereby charged upon the Consolidated Fund.

Further appropriation 2005 and transfer to Contingencies Fund.

**3.** A further sum not exceeding six Maltese liri, to meet expenditure in respect of the financial year 2005 under the Votes specified in the Second Schedule to this Act shall be and the same is hereby charged upon the Consolidated Fund, provided that such sum shall be transferred to the Contingencies Fund in replacement of withdrawals made out of this Fund to cover the services detailed in regard to such Votes in the Supplementary Estimates of Expenditure for the financial year 2005.
