ACT No. XIV of 2004

AN ACT to appropriate a sum not exceeding six hundred and fifty-three million, three hundred and twenty-two thousand, five hundred and fifty-four Maltese liri for the service of the financial year 2005.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Appropriation (2005) Act, 2004. Short title.
2. A sum not exceeding six hundred and fifty-three million, three hundred and twenty-two thousand, five hundred and fifty-four Maltese liri shall be and the same is hereby charged upon the Consolidated Fund to meet expenditure during the financial year 2005 under the Votes specified in the Schedule to this Act. Appropriation.
