Abbozz ta' Liġi msejjah

ATT sabiex ikompli jemenda l-Kodiċi Kriminali, Kap. 9.

Il-President, bil-kunsens u bil-parir tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità tal-istess, harġet b'liġi dan li ġej:

1. It-titolu fil-qosor ta' dan l-Att huwa l-Att tal-2016 li jemenda l-Kodiċi Kriminali (Emenda Nru. 3) u dan l-Att għandu jinqara u jinftiehem haġa waħda mal-Kodiċi Kriminali, hawn iżjed 'il quddiem imsejjah "il-Kodiċi".

Titolu fil-qosor.

Kap. 9.

2. L-artikolu 515 tal-Kodiċi għandu jiġi emendat kif ġej:

Emenda tal-artikolu 515 tal-Kodiċi.

(a) fis-subartikolu (1) tiegħu l-kliem "wara att ta' akkuża" għandhom jiġu mħassra; u

(b) minnufih wara s-subartikolu (2) tal-artikolu 515 għandu jizdied dan is-subartikolu ġdid li ġej:

"(3) Fil-każ li ssir ir-referenza bis-saħħa tal-artikolu 515(1)(a), għandhom, *mutatis mutandis*, japplikaw id-dispożizzjonijiet tal-artikoli 574 sa 587."

Għanijiet u raġunijiet

L-għan ta' dan l-Abbozz huwa sabiex f'każijiet eċċezzjonali fejn jiġi ppruvat li tkun saret amminstrazzjoni hażżina tal-ġustizzja l-Qorti tal-Appell Kriminali jkollha s-setgħa tistharreg mill-ġdid każ li jkun ġie referut lilha wara kundanna minn kwalsiasi Qorti ta' Ġustizzja Kriminali.

**A Bill

AN ACT further to amend the Criminal Code, Cap. 9.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:-

Short title.

1. The short title of this Act is the Criminal Code (Amendment No. 3) Act, 2016, and this Act shall be read and construed as one with the Criminal Code, hereinafter referred to as "the Code".

Cap. 9.

Amendment to article 515 of the Code.

2. Article 515 of the Code shall be amended as follows:

(a) in sub-article (1) thereof the words "on indictment" shall be deleted; and

(b) immediately after sub-article (2) thereof there shall be added the following the new sub-article:

"(3) In the case of a reference made under the provisions of article 515(1)(a) the provisions of article 574 to 587 shall, *mutatis mutandis*, apply.

Objects and Reasons

The aim of this Bill is to empower the Court of Criminal Appeal, in exceptional cases, to treat a new any conviction meted out by any Court of Criminal Justice where a miscarriage of justice took place.
