ATT biex jemenda l-Att dwar il-Forzi Armati ta' Malta, Kap. 220.

IL-PRESIDENT bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità tal-istess, harget b'liġi dan li ġej:-

1. (1) It-titolu fil-qosor ta' dan l-Att huwa l-Att tal-2016 li jemenda l-Att dwar il-Forzi Armati ta' Malta, u dan l-Att għandu jinqara u jinftiehem haġa waħda mal-Att dwar il-Forzi Armati ta' Malta, hawnhekk iżjed 'il quddiem imsejjah "l-Att prinċipali".

Titolu fil-qosor u bidu fis-sehh.

Kap. 220.

(2) Dan l-Att għandu jidhol fis-sehh f'dik id-data li l-Ministru responsabbli għad-difiża jista' b'avviż fil-Gazzetta jistabbilixxi, u dati differenti jistgħu jiġu hekk stabbiliti għal dispożizzjonijiet differenti jew għanijiet differenti ta' dan l-Att.

2. Minnufih wara s-subartikolu (4) tal-artikolu 4 tal-Att prinċipali, għandu jizdied is-subartikolu ġdid li ġej:

Emenda tal-artikolu 4 tal-Att prinċipali.

"(5) Minkejja d-dispożizzjonijiet ta' qabel ta' dan l-artikolu, u sa fejn l-għoti ta' pensjonijiet hija kkonċernata:

(a) kull regolament magħmul taht dan l-artikolu jista' b'effett retroattiv jikkonferixxi benefiċċju fuq jew inehhi diżabilità annessa ma' kull persuna jew klassi ta' persuni;

(b) l-ebda regolament magħmul taht dan l-artikolu m'għandu jkollu effett qabel ma jkun approvat mill-Kamra tad-Deputati permezz ta' riżoluzzjoni; u

(ċ) kull pensjoni mogħtija taħt dan l-Att għandha tinhadem skont id-dispożizzjonijiet li huma fis-seħħ fid-data attwali tal-irtirar tal-uffiċjal."

Għanijiet u Raġunijiet

L-għan ta' dan l-Abbozz ta' Liġi huwa li jintroduċi mekkanizmu bil-għan li d-dispożizzjonijiet relatati mal-għoti ta' pensjoni tas-servizz lill-uffiċjali tal-Forzi Armati ta' Malta, jkunu jistgħu jiġu applikati b'mod retroattiv.

A BILL
entitled

AN ACT to amend the Malta Armed Forces Act, Cap. 220.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

1. (1) The short title of this Act is the Malta Armed Forces (Amendment) Act, 2016, and this Act shall be read and construed as one with the Malta Armed Forces Act, hereinafter in this Act referred to as "the principal Act".

Short title and commencement.

Cap. 220.

(2) This Act shall come into force on such a date as the Minister responsible for defence may by notice in the Gazette establish, and different dates may be so established for different provisions or different purposes of this Act.

2. Immediately after sub-article (4) of article 4 of the principal Act, there shall be added the following new sub-article:

Amendment of article 4 of the principal Act.

"(5) Notwithstanding the foregoing provisions of this article, in so far as the granting of pensions is concerned:

(a) any regulations made under this article may have retrospective effect in order to confer a benefit upon, or remove a disability attaching to any person or class of persons;

(b) no regulation made under this article shall have effect unless it has received the prior approval of the House of Representatives signified by resolution; and

(c) any pension granted under this Act shall be computed in accordance with the provisions in force at the actual date of the officer's retirement."

Objects and Reasons

The object of this Bill is to introduce a mechanism to the effect that the provisions relating to the granting of pension service to officials of the Armed Forces of Malta may be applied retroactively.
