ATT biex jemenda l-Att dwar Ġieh ir-Repubblika, Kap. 251.

IL-PRESIDENT, bil-parir u l-kunsens tal-Kamra tad-Deputati, imlaqqgħa f'dan il-Parlament, u bl-awtorità tal-istess, harget b'liġi dan li ġej:-

1. It-titolu fil-qosor ta' dan l-Att hu l-Att tal-2015 li jemenda l-Att dwar Ġieh ir-Repubblika, u dan l-Att għandu jinqara u jiftiehem haġa waħda mal-Att dwar Ġieh ir-Repubblika, hawnhekk iżjed 'il quddiem f'dan l-Att imsejjah "l-Att prinċipali".

Titolu fil-qosor.

2. Is-subartikolu (4) tal-artikolu 16 tal-Att prinċipali għandu jiġi emendat kif ġej:

Emenda tal-artikolu 16 tal-Att prinċipali.

(a) fil-paragrafu (b) tiegħu, minflok il-kliem "tal-Pulizija; u", għandhom jidhlu l-kliem "tal-Pulizija;"

(b) fil-paragrafu (ċ) tiegħu, minflok il-kliem "Korrettivi ta' Malta.", għandhom jidhlu l-kliem "Korrettivi ta' Malta; u"; u

(ċ) minnufih wara l-paragrafu (ċ) tiegħu għandu jżied il-paragrafu ġdid li ġej:

"(d) il-Forza tal-Għajnuna u Salvataġġ fi hdan id-Dipartiment tal-Protezzjoni Ċivili."

entitled**

AN ACT to amend the Ġieħ ir-Repubblika Act, Cap. 251.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives in this present Parliament assembled, and by the authority of the same as follows:-

1. The short title of this Act is the *Ġieħ ir-Repubblika* Short title.
(Amendment) Act, 2015, and this Act shall be read and construed as one with the *Ġieħ ir-Repubblika* Act, hereinafter referred to as "the principal Act". Cap. 251.

2. Sub-article (4) of article 16 of the principal Act shall be amended as follows: Amendment of article 16 of the principal Act.

(a) in paragraph (b) thereof, for the words "Police Force; and", there shall be substituted the words "Police Force;"

(b) in paragraph (c) thereof, for the words "Correctional Services.", there shall be substituted the words "Correctional Services; and"; and

(c) immediately after paragraph (c) thereof there shall be added the following new paragraph:

"(d) the Assistance and Rescue Force within the Civil Protection Department."

Objects and Reasons

The object of this Bill is to amend the *Ġieh ir-Repubblika* Act in order to provide for the widening of the meaning of "disciplined forces" for the purposes of the Act.
