Titolu fil-qosor.

Kap. 409.

2. Fl-artikolu 2 tal-Att prinċipali, it-tifsira "turist" għandha tiġi sostitwita b'dan li ġej:

Emenda tal-artikolu 2 tal-Att prinċipali.

" "turist" tfisser persuna li, għal perjodu ta' mhux aktar minn sena waħda konsekuttiva, tivvjaġġa lejn u toqgħod ġewwa postijiet li jinsabu barra mill-ambjent ordinarju tal-istess persuna u dan għal skop ta' divertiment, negozju jew għal xi raġuni personali oħra barra mill-għan illi wiehed jimpejga ruħu jew jistabilixxi n-negozju tiegħu fil-post illi jżur."

**A BILL
entitled**

*AN ACT to amend the Malta Travel and Tourism Services Act,
Cap. 409.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

Short title.

1. The short title of this Act is the Malta Travel and Tourism Services (Amendment) Act, 2015, and this Act shall be read and construed as one with the Malta Travel and Tourism Services Act, hereinafter referred to as "the principal Act".

Cap. 409.

Amendment of article 2 of the principal Act.

2. In article 2 of the principal Act, for the definition "tourist" there shall be substituted the following:

" "tourist" means any person who is travelling to and staying in places outside his usual environment for not more than one consecutive year for leisure, business and other personal purpose other than by taking up employment or to establish a business in the place visited."

Objects and Reasons

The object of this Bill is to amend the Malta Travel and Tourism Services Act, by updating the definition "tourist" contained therein.
