*An Act to amend various laws relating to the functions of
Members of Parliament*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives in this present Parliament assembled, and by the authority of the same as follows:-

1. The title of this Act is the Functions of Members of Parliament (Various Laws) Amendment Act, 2013. Short title.

2. In sub-paragraph (ii) of paragraph 13 of the Second Schedule to the Auditor General and National Audit Office Act the words "the Minister responsible" shall be substituted by words "the Minister or any another Member of the House of Representatives responsible". Amendment to the Auditor General and National Audit Office Act. Cap. 396.

3. Sub-article (5) of article 4 of the Malta Crafts Council Act shall be substituted by the following: Amendment to Malta Crafts Council Act. Cap. 421.

"(5) A person shall not be eligible to be a member of the Council if he has been convicted of any:

 - (a) crime against property and public safety;
 - (b) crime against public trust;
 - (c) crime against public trade; or
 - (d) offence under the Trade Descriptions Act." Cap. 313.

Amendment to the Occupational Health and Safety Authority Act. Cap. 424.

4. In paragraph (a) of sub-article (5) of article 8 of the Occupational Health and Safety Authority Act the words "or a member of the House" shall be deleted.

Amendment to the Co-operative Societies Act. Cap. 442.

5. Sub-article (3) of article 4 of the Co-operative Societies Act shall be substituted by the following:

"(3) No person shall be appointed or shall remain a member of the Board if that person is an officer or member of any society or the Apex organization."

Amendment to the Sports Act. Cap. 455.

6. Paragraph (a) of sub-article (6) of article 4 of the Sports Act shall be deleted and paragraphs (b), (c), (d), (e) and (f) shall be re-numbered as paragraphs (a), (b), (c), (d) and (e) respectively.

Amendment to the Malta Enterprise Act. Cap. 463

7. Paragraph (a) of sub-article (7) of article 10 of the Malta Enterprise Act shall be deleted and paragraphs (b), (c), (d), (e) and (f) shall be re-numbered as paragraphs (a), (b), (c), (d) and (e) respectively.

Amendment to the Maltese Language Act. Cap. 470

8. Sub-article (2) of article 9 of the Malta Language Act shall be substituted by the following:

"(2) No person shall be qualified to be a member of the Council or of any of its organs if he is a Judge or Magistrate."

Amendment to the Malta Film Commission Act. Cap. 478

9. Paragraph (a) of sub-article (5) of article 3 of the Malta Film Commission Act shall be deleted and paragraphs (b) and (c) shall be re-numbered as paragraphs (a) and (b) respectively.

Amendment to the Domestic Violence Act. Cap. 481

10. Sub-article (2) of article 3 of the Domestic Violence Act shall be deleted and sub-article (3) and (4) shall be re-numbered as paragraphs (2) and (3) respectively.

The objects and reasons of this Bill are to amend various laws to remove restrictions upon the performance of certain specific functions of the Members of the House of Representatives.
