2. Is-subartikolu (1) tal-artikolu 3 tal-Att prinċipali għandu jiġi emendat kif ġej:

Emenda tal-artikolu 3 tal-Att prinċipali.

(a) fil-paragrafu (k) tiegħu, minflok il-kliem "u dokumentarji:" għandhom jidhlu l-kliem "u dokumentarji; jew"; u

(b) minnufuh wara l-paragrafu (k) tiegħu, għandu jizjed il-paragrafu ġdid li ġej:

"(l) il-forniment ta' servizzi ancillari lill-industriji kreattivi, il-logistika inkluż il-magazzinar doganali u t-twettiq ta' ordnijiet, l-edukazzjoni u t-taħriġ, l-ippjanar u l-iddisinjar arkitettoniku u tal-inginerija (inkluż l-ippjanar tad-disinn u l-eżekuzzjoni għal avvenimenti kbar) l-industrija tal-avjazzjoni u dik marittima, servizzi lill-industrija

ACT No. XXXII of 2015

AN ACT to amend the Business Promotion Act, Cap. 325, and to make provision with respect to matters ancillary thereto or connected therewith.

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:-

1. The short title of this Act is the Business Promotion (Amendment) Act, 2015, and this Act shall be read and construed as one with the Business Promotion Act, hereinafter referred to as "the principal Act".

Short title.

Cap. 325.

2. Sub-article (1) of article 3 of the principal Act shall be amended as follows:

Amendment of article 3 of the principal Act.

(a) in paragraph (k) thereof, for the words "and documentaries:" there shall be substituted the words "and documentaries; or"; and

(b) immediately after paragraph (k) thereof, there shall be added the following new paragraph:

"(l) the provision of services ancillary to the creative industries, logistics including customs warehousing and order fulfilment, education and training, architectural and engineering design and planning (including planning design and execution for large events), aviation and maritime industries,

services to the energy industry, medical and health services and life sciences:".
