Il-kuntratt tal-kera intemm fit-30 ta' Ġunju 2006 iżda qed tintalab approvazzjoni għal estensjoni ta' sitt xhur mill-Ministeru tal-Finanzi qabel ma jkunu kompluti l-uffiċini fil-kumpless tal-Biċċerija.
