
Dear Mr. Mercieca,




Tajjeb nghid illi jien kont gejt imlaqqa' ma' Clint Scerri xi zmien qabel (granet wara li Dr. Michael Falzon gie mahtur Segretarju Parlamentari ghal-Lands). Hu kien gie ipprezentat lid-Diretturi fi hdan il-GPD mid-Direttur Generali tad-Dipartiment bhala l-persuna li se tkun il-link bejn is-Segretarjat Parlamentari u d-dipartiment. 

Fl-istess file kien hemm ittra ohra, jekk niftakar sew mibghuta minn Avukat f'isem Marco Gaffarena li kienet tghid illi l-imsemmi Marco Gaffarena, kien sid ta' kwart indiviz ta' dan l-istess palazz u peress li kien jaf li l-palazz qed jintuza mill-gvern, xtaq li l-Gvern jespropija l-bicca tieghu bi tpartit ma' xi-artijiet agrikoli tal-Gvern li pero' kienu diga mikrija lilu. Jien fhemt lil Clint u lis-Sur Gaffarena li biex issir esproprijazzjoni, irid l-ewwel ikollna l-approvazzjoni ta' xi membru tal-kabinett u mbaghad irridu naraw minn fejn ser jigu il-fondi sabiex issir l-esproprijazzjoni. 




Jiena cert minn din id-data ghax dakinhar stess ktibt il-minuta numru 123 fil-file L108/84 (kopja annessa dok B). Clint indikali bic-car liema kienu l-propjetajiet li kellhom jitpartu. Hu stqarr mieghi li Marco kien jaf kemm gew l-istimi u qalli ukoll li Marco ser jaccetta li dawn il-propjetajiet minflok il-kwart indiviz li kellu minn 36, Triq Zekka, il-Belt Valletta, u jiehu d-differenza fi flus. Jien minn naha tieghi, nerga' nsostni li lill Marco qatt ma tajtu figuri ta' kemm gew stmati il-propjetajiet li kien qed jitlob.

Ghedt biss kif kienu l-affarijiet, u spiccajt il-minuta "You may wish to direct way forward".
