**ACT No. XXI of 1997**

*AN ACT to repeal the Opposition Nominees Act, 1996*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the Opposition Nominees (Repeal) Act, 1997, and shall be read and construed as one with the Opposition Nominees Act, 1996, hereinafter referred to as “the principal Act”.

Act IX of 1996.

Repeal of the principal Act.

2. The principal Act is hereby repealed.

Transitory.

3. Any member of any board appointed thereon in virtue of the provisions of the principal Act shall, notwithstanding the repeal of the principal Act, remain in his office until the end of the term of his appointment.
