**ACT No. XXIV of 1997**

*AN ACT to amend the Local and other Loans Act, 1997.*

BE IT ENACTED by the President, by and with the advice and consent of the House of Representatives, in this present Parliament assembled, and by the authority of the same as follows:—

1. This Act may be cited as the Local and other Loans (Amendment) Act, 1997, and shall be read and construed as one with the Local and other Loans Act, 1997, hereinafter referred to as “the principal Act”.

Short title.

Act VI of 1997.

2. In subsection (1) of section 2 of the principal Act, for the words “one hundred million Maltese liri” these shall be substituted the words “one hundred and seventy-five million Maltese liri”.

Amendment of section 2 of the principal Act.

3. In subsection (1) of section 3 of the principal Act, immediately at the end of paragraph (b) thereof, there shall be inserted the following new paragraph (c):—

Amendment of section 3 of the principal Act.

“(c) a sum not exceeding seventy-five million Maltese liri to make good part of the deficit expected to be incurred by the Consolidated Fund to meet expenditure during the year 1997.”.
