**LOCAL COUNCILS ACT
(CAP. 363)**

**Administrative Committees for Communities
(Amendment) Regulations, 2019**

IN EXERCISE of the powers conferred by article 72 of the Local Councils Act, the Minister for Justice, Culture and Local Government, has made the following regulations:-

Citation. **1.** The title of these regulations is the Administrative Committees for Communities (Amendment) Regulations, 2019 and they shall be read and construed as one with the Administrative Committees for Communities Regulations, hereinafter referred to as "the principal regulations".

Adds new regulation to the principal regulations.

2. Immediately after regulation 13 of the principal regulations, there shall be added the following new regulation:

"Postponement of elections of Administrative Committees.

14. The elections for the members of the Administrative Committees which are to be held in May 2019, shall be postponed and held in any other date as published by regulations issued by the Minister."
